In order for your local Environmental Health Officer to investigate your noise concerns in the most effective manner, please complete and return the form and accompanying 'Log Sheet'.

It is important that you accurately record the noise nuisance as it affects you, providing as much information as possible. This information must also identify the source of the noise (at least the property address). It is recommended that you record the noise disturbances on the attached 'Log Sheets' for the time period specified for that particular type of noise. This information will then be used to determine the nature of the noise and possibly identify a pattern of the times and days the noise typically occurs. Details provided will then assist the Environmental Health Officer to investigate your noise issue.


